

#### **AUDITIONS 2024**

Deadline for submitting applications: April 26, 2024

## 1. SUBJECT

The Musical and Symphonic Institution of FVG (hereinafter referred to as the Institution), headquartered at Via San Francesco, 34 in Udine, announces an AUDITION for the following instruments:

- FLUTE (optional piccolo)
- OBOE (optional English horn)
- CLARINET (optional bass clarinet and E-flat clarinet)
- HORN
- VIOLIN
- VIOLA
- CELLO
- DOUBLE BASS

The resulting ranking, determined by the Audition Panel, will be valid for 12 months from the publication date and may be used for fixed-term contracts or self-employment, to be defined on a case-by-case basis according to programming needs, including for a single production.

## 2. ADMISSION REQUIREMENTS

- A. Minimum age of 18;
- B. Italian citizenship or citizenship of a European Union country. For non-EU citizens, only candidates holding a long-term EU residence permit allowing work will be admitted (attach a copy of the permit);
- C. Possession of an academic diploma (old system) or a first-level degree in the instrument for which the candidate is applying, obtained from a State Conservatory or equivalent music institute, or an equivalent qualification obtained abroad;
- D. Physical fitness for the full and unconditional performance, on-site and off-site, of the duties specified in the future employment contract, as well as for professional performance;
- E. Absence of criminal convictions resulting in dismissal from public administration





employment and no previous dismissal from employment due to obtaining the appointment through false or invalid documents.

The above requirements must be met by candidates by the deadline for submitting applications. Applications that do not meet the above requirements will be excluded from the selection process.

#### 3. APPLICATION FOR ADMISSION

The application for participation must be sent:

The application for participation must be received no later than 11:59 PM on April 26, 2024.

The submission of documentation is at the exclusive risk of the candidate; therefore, no responsibility of the Institution is assumed if, due to technical and/or computer errors or other reasons, the application does not arrive by the above-mentioned deadline. Applications received after the deadline, even for reasons beyond the candidate's control, will not be considered. Incomplete applications or those submitted by hand or sent by postal mail will also not be considered.

The application must be accompanied by the following documents:

- application form;
- copy of a valid identity document;
- curriculum vitae, duly signed, prepared in European format;
- self-certification of academic qualifications (which may be requested later for verification).

Candidates must present themselves with a valid identity document. Non-EU citizens must present themselves with a valid identity document and a copy of the residence permit or any other document proving compliance with the requirement stated in point 2, letter B of this notice.

The declaration of circumstances or information not corresponding to the truth, verifiable at any time, will result in exclusion from the selection process and, in case of subsequent verification,



from employment or confirmation of service.

Candidates who will not be admitted are those who:

- submit the application after the specified deadline;
- do not meet the requirements specified in point 2.

Participation in the audition is free of charge; travel and accommodation expenses will be borne by the applicants.

Submitting the application implies unconditional acceptance of the unchallengeable judgment of the Examination Committee.

#### **4.AUDITION PANEL**

The audition panel will be appointed by the Artistic Director of the Institution. The decisions of the judges are final.

#### **5.EXAMINATION TESTS**

Auditions will take place starting from May 6, 2024; the date and time of the auditions will be communicated via email to all candidates who have submitted the application for admission. Any changes to the schedule and examination program will be promptly communicated to the parties concerned.

The Institution will provide candidates with an accompanist pianist.

## **6.EXAMINATION PROGRAMS**

The Audition Panel reserves the right to only perform part of the program and to re-hear the candidates within the same day of the audition appointment..

## 7.RANKING

Following the auditions, an eligibility ranking will be drawn up, indicating the rating obtained by each eligible candidate.

The ranking will be valid for 12 months from publication.

#### 8.PROCESSING OF PERSONAL DATA

In accordance with GDPR – EU Regulation 2016/679, personal data provided by candidates will be collected by the Institution and will be used not only for participation in the audition but also subsequently for the possible establishment of an employment relationship and for purposes related to the management of the same relationship.

The processing of the data in question may be carried out using electronic or automated means for storing, managing, and linking the data. The personal data concerned will be stored and



controlled in such a way as to minimize, through the adoption of suitable and preventive security measures, the risk of loss, destruction, unauthorized access, or processing not allowed and not in accordance with the purposes of collection.

Providing the data is mandatory for the evaluation of participation requirements, under penalty of exclusion of the candidate from the audition.

The same data may only be communicated to the Institution's personnel involved in the competition procedures and to internal and external members of the examination committees. Each candidate may exercise their rights as expressed by GDPR – EU Regulation 2016/679; these rights can be exercised against the Institution, the data controller.
